

2009 Stars and Stripes Freedom Festival Vendor Rules / Guidelines

* Upon arrival at the Festival Grounds, vendors are required to check in at the Information Tent. Vendor set-up hours are Saturday July 4th, 8:00 a.m. until 9:40 a.m.

* No vehicles are allowed to stay within the festival grounds except for booth-setup. All vehicles must be removed by 9:45 a.m. on Saturday, July 4th.

* Vendors agree to be present for all of scheduled festival hours. The Festival will be held rain or shine. Vendors should be prepared for inclement weather. There will be no refunds due to inclement weather. Vendors are asked NOT to dismantle their booths before the festival ends as this is disruptive to shoppers and other festival vendors.

*The Stars and Stripes Freedom Festival Hours are 10:00 a.m. until 2:00 p.m., Saturday, July 4th.

*No alcoholic beverages are allowed inside the festival grounds.

*No hawking, soliciting, mass gathering, shouting or amplification of sound in Festival area outside your allotted booth space without written consent of the Festival Committee.

*The Stars and Stripes Freedom Festival Committee reserves the right to refuse space to an exhibitor who does not comply with these rules. The Festival Committee shall be the sole judge as to the suitability of an applicant's merchandise.

*Booth display should not exceed established boundaries, 10' wide by 10' deep. Allotted space is strictly enforced. Any vendor needing additional space will be expected to reserve two (or more) spaces as needed. Canopies, tents, connecting wires and/or stakes must be contained within vendor assigned space. Vendors are responsible for all necessary display props, including tables, table covers, chairs, extension cords, etc.

*Tables should be covered to the ground if packing materials are placed underneath the tables. Please keep your assigned booth space clean and litter free.

* Once vendor spaces have been assigned, there will be no refunds unless approved by the Festival Committee in the event of an emergency.

The applicant hereby agrees to defend, indemnify, and hold harmless the Stars and Stripes Freedom Festival, Shiny Badges Ball Inc. their officers, agents, successors, and assignees from and against any and all claims, demands, actions or causes of actions, suits at law or inequity of any nature or character arising out of or by reason of any act of omission of the second party or its agents in the performance of rights, duties, and obligations of the second party under this agreement. The second party understands that Shiny Badges Ball Inc. assumes no responsibility or liability for any property of the second party, which may be located on the above-described premises. For and in consideration of permission to participate in the Stars and Stripes Freedom Festival the specified above shall be subject to acts of God or any condition or circumstances beyond the control of Shiny Badges Ball Inc which shall prevent the carrying out of some or all of, upon the occurrence of such event, shall have the right to terminate this agreement without liability of any nature.**
